



## National Detention Appeal Procedures BS MOU Member States

Section 3.14 of the BS MOU states that “the owner or the operator of a ship will have the right of appeal against a detention decision to higher administrative Authority or to the court of competent jurisdiction, according to the law in each country. However, an appeal shall not cause the detention to be suspended”.

Owners or operators should be advised to use official national procedure according the national jurisdiction of the country where the detention order was issued, if they wish to appeal against a detention order.

<p>The appeal must be submitted to the Executive director of the Executive Agency “Maritime administration” <b><u>through the regional directorate of the Executive agency “Maritime administration</u></b>, where the notice of detention was issued.</p> <p>The decision for detention may be appealed directly to the court in accordance with the Administrative procedure Code of the Republic of Bulgaria, Article 148. The appeal must be submitted to the Regional Administrative court within the deadline of 14 from the date of the acknowledgement of the notice of the detention. The appeal must be submitted through the regional directorate of the Executive agency “Maritime administration”, where the notice of the detention was issued.</p> <p>An appeal shall not cause the detention to be suspended.</p>

<p><b>Other relevant information.</b></p> <p>If the owner, operator or official representative of the ship disagrees with an outcome of the decision taken by MTA or Ministry of Economy and Sustainable Development of Georgia, he has the right to appeal against the Notice of Detention.</p> <p>The appeal can be directly submitted to the court of Georgia in accordance with the art.22 of Administrative Procedure Code. The appeal must be submitted to the court, within the deadline of 30 days from the receiving of the official notification.</p> <p>The notice of detention should be appealed in the following courts:</p> <p>Batumi City Court - 30, Zubalashvili str. Batumi, post code: 6010 Tel. Number: +995 (493) 228237; e.mail: <a href="mailto:Poti@court.ge">Poti@court.ge</a> - In the case of detention in Poti Port and Kulevi Port.</p> <p>Due to the fact that the applicant is a foreign entity, in accordance with Georgian law, there must be submitted the power of attorney, duly translated and authenticated.</p>

<p><b>Other relevant information.</b></p> <p>After the detention of a vessel, RNA (PSCO) shall inform the Master of that vessel about his right of appeal against the Notice of Detention.</p> <p>The national legislation states:</p> <ol style="list-style-type: none"> <li>In case of detention on account of a Port State Control inspection, the Owner, the Operator or the ship's official representative in Romania has, as compensation, the right of appeal, as foreseen in Art. 20 of the Government Decision No.811/2010 transposing EC Directive 2009/16/EC on PSC, as amended.</li> <li>The appeal procedure is governed by the Law 554/2004, namely: Submitting the complaint to the General Director of the Romanian Naval Authority, address: Clădirea ANR, poarta nr. 1, 900900 Constanta Port, Romania, not later than 15 days, as the first action of the appeal; - If the result of the decision taken by RNA is still not satisfactory, the Owner, the Operator or the Ship's official representative in Romania has the right of appeal against the Notice of Detention to Constanta Court of Appeal not later than 6 months from the issuing date of the Notice of Detention.</li> </ol> <p>The appeal procedure does not lead to the suspension of the detention.</p>
